2. POLICE REPORT

- 2.1 Police will be targeting speeding traffic in and around Biggar and believe that this has already been stated in the local Facebook pages. They are looking at Station Road, Carwood, Road and both east and west entrances to Biggar. It was noted that vehicles stopped previously were driven mainly by local residents
- **2.2** Rural crime again quad bikes are the main target and there has been some success in recovery

- 3.1 It was noted that talks with Stagecoach are in long term negotiations. The timetables at the bus stops have the wrong times on them

Chair pointed out that he has no written agreement on this from South Lanarkshire Council and Councillor McAllan would look into this.

- 4.3 Councillor Allison re bridge at Carstairs, it won't be opening anytime soon. Has had a meeting with SLC Chief Executive and leader of the Council and both are very supportive of the bridge being replaced but this will be a long term project. This is leading to major traffic delays at Hyndford Bridge and also Boat Bridge. The Council has been inundated with letters of support for a new bridge at Carstairs

5.1 Chair has still not been contacted by Police Scotland to reschedule meeting regarding Hogmanay 2017, however he has received an application form for

Hogmanay 2018 which requires more information than previous applications, such as Risk Assessments, Traffic Management, Medical, Fire and Marshall details. Chair will liaise with Police Operations.
